



## **Oliver McGowan Mandatory Training on Learning Disability and Autism Tier 1 Webinar**

### **Introduction**

Health inequalities are everyone's problem, and everyone has a role to play in ensuring we reduce them. Although you may not provide direct care to people with learning disabilities or autistic people, you play a role in ensuring the services they receive and engage with meet their needs and are effective.

This training is aimed at developing your awareness and understanding about how to work, communicate and live alongside people who are autistic or have a learning disability. While doing the training, we ask that if the trainers tell experiences that are not related to your role, you reflect on their experience and how that may apply to you in your role, and where you might be able to make changes, as well as your wider role within society.

### **Learning Outcomes**

After attending this course, learners will be able to:

- Understand that everyone is different and has different needs
- Give an example of how you can support a person with a learning disability or an autistic person differently
- Give an overview of what 'reasonable adjustments' means
- Identify any changes in practice needed to enable excellent care and services for people with a learning disability and autism

### **Accessing the webinar**

You will need access to Microsoft Teams to access the training. If you do not use Microsoft Teams already, you can download the app for free on your smart phone or laptop from your app store. You must have access to a webcam and microphone so you can engage in the session.

You must arrive early for the webinar so the trainers can make a prompt start, as there is a lot of content for an hour. The webinar will last for one hour. If you cannot log on to the webinar from the start, please book another webinar as joining late will be disruptive for the trainers and you will be asked to leave. The training is delivered by a facilitator, a trainer with learning disabilities and an autistic trainer. Please be mindful when discussing their personal experiences, and please actively engage with the session.

### **Adjustments of Microsoft Teams**

**Live captions** - clicking the three dots at the top of your screen, language and speech, turn on live captions.

**Spot lighting** – if you are lip reading, it may be helpful to spotlight the trainers by hovering over their name, pressing the three dots, pin. Pinning the trainers will enlarge their window.
