## Who Should Attend?

It is aimed at all qualified Dental Care professionals. It meets the new GDC requirements for enhanced CPD.

Aim: This is a bespoke course which will enable dental care professionals to fulfil the minimum verifiable CPD requirement highly recommended by the GDC. It is an interactive course covering Medical emergencies, Disinfection and decontamination, Radiology and radiation protection, Legal and ethical issues and complaints handling, Oral cancer and Safeguarding children and vulnerable adults.

- Discuss the drugs and equipment required to manage adult/paediatric emergencies in practice. •

- Recognise the flow of dental instruments within the decontamination room to maintain infection control
- Recognise the requirements to optimise infection control in a dental environment
- State the hazards of exposure to radiation •
- Describe the quality assurance required for exposure to radiation
- Recall the requirements for IRR1999 and IR(ME)R 2018
- Identify the ethical issues affecting dental care and how these may present in primary care
- Have knowledge of GDPR and how this may affect you in practice.
- Have knowledge of current consent issues and their implications.
- Apply GDC standards to everyday practice
- Explain how the response to ethical dilemmas may be perceived and how this can be optimised in patient care
- Describe the presentation and aetiology of oral cancers and discuss management principles in primary care
- Describe the role of the GDP in managing oral cancer
- Identify types of abuse and neglect and dental neglect
- Discuss how to manage and report protection cases
- Recognise the importance of team approach for safeguarding issues
