### Legal and Ethical problems in Paediatric Dentistry

### <u>Aims</u>

By the end of the sessions, participants will be able to:

- Relate to the child as a person with autonomy
- Understand the ethical theory underpinning dental treatment of the child
- Differentiate between scenarios where sharing information about a child is not advised and where it is beneficial
- Evaluate the child's family situation and enable valid consent for dental treatment to occur

### **Objectives**

- Consider fictional cases where ethical dilemmas exist
- Assess the ethical theory and principles underpinning our decision-making
- Examine the main laws related to children's dental care in the UK and worldwide

### **Dental trauma update**

#### Aims

To ensure that the third of the population of pre-teenage children who damage their teeth are not resigned to loss of an incisor in later life because of inaccurate diagnosis and poor treatment of the emergency condition.

To have knowledge of a variety of options for the restoration of the traumatised dentition

#### Objectives

- Understand the epidemiology and aetiological factors involved in traumatic injuries to the teeth
- Recognise tissues involved in the range of traumatic oro-dental injuries
- Be aware of signs of NAI and local protocol to safeguard children at risk
- To understand the biological principles behind dental injury and subsequent healing
- To have some knowledge of the restorative options for;
  - i. Fractured teeth
  - ii. Non-vital teeth
  - iii. Missing teeth
  - iv. Ankylosed teeth
  - v. De coronated teeth
